Overview of the challenge

Key challenges included standardising service delivery across the estate, ensuring full visibility of compliance and implementing a scalable maintenance model aligned with regulatory requirements.

In addition, the nature of care environments meant that any maintenance activity had to be carefully managed to minimise disruption to residents and staff. Ensuring systems remained operational at all times, while coordinating access across multiple sites with varying operational needs, added further complexity to service delivery.
